Feminist Development Theory

- Women In Development (WID)
 - Problematize gendered disparities
 - Boserup, 1970; Rathgeber, 1990
- Women And Development (WAD)
 - Framework focused on social and cultural context
 - Visvanathan, 1997
- Gender And Development (GAD)
 - Rejection of gender essentialism and embrace of decolonialism and emancipation
 - ▶ Young, 1993
- Women, Environment, and Development (WED)
 - Include gendered knowledges and agency
 - Merchant, 1980; Shiva, 1989; Agarwal, 1991
- Feminist political ecology
 - Gender and gender relations as key variable in resource allocation
 - Elmhirst, 2015; Nightingale, 2006

Women and Entrepreneurship

- Globally, less women entrepreneurs (Kim, 2007; Minniti, 2009)
- Disparity in entrepreneurship and macroeconomic representation (Liedholm, 2002; Minniti, 2009)
- Market opportunities exist for women entrepreneurs (Horrell & Krishnan, 2007)
- Knock-on effects of increased involvement are abundant (Goetz & Gupta, 1996; Luke & Munshi, 2011)




 Common media portrayal: bride kidnapping (Kleinback & Salimjanova, 2007)

- Numerous barriers to entrepreneurial success (Giovarelli, 2004; Simpson, 2006)


Site Selection - Alay Rayon

Data Collection


- 23 villages
- 1,234 household surveys
- ▶ 6,581 individuals
- 2,063 children
- > 275 migrants
- 52 in-depth interviews
 - 27 semi-structured
 - 13 women business owners
- Detailed field notation
- Key informant interview

Research Questions

- What are the gendered perceptions of women's entrepreneurship in Alay?
- What role does women's entrepreneurship play in empowerment and gender relations?
- What are the experiences of women entrepreneurs and what role does the women's business association play in both their nascent stages and long-term success?






Early Findings



- Polarization of women's economic integration
- Importance of vocational training and human capital development for women's economic empowerment
- Antecedents leading to and perpetuating women's disproportionate vulnerability

Next steps...

- Potential policy recommendations:
 - Childcare support
 - Increased access to structured business associations
 - Expanded vocational training
 - Increase potable water access
- Human capital development
- Societal advancement of gender equality (socially, politically, and economically)
