


Positive Effect

In our example, it has been determined that the factors that are likely to increase citizens' trust in local government are

"Wage Status-Wage Employee-%3;
Wage Status-Own account work-%6.8;

Trust in the Community-%22.2;
Accessing to the information about budget of Local Government-%1.9" respectively.

Negative Effect

- ► However, it has been determined that the factors affecting trust in the direction of decreasing are:
- Unemployed- %6,0
- Voting-%-5.1;
- Being informed by Local Government- %-11.8;
- Influencing the budget of Local Government-%-5.6" respectively.

Reccomendations

- ■Improvement of general trust and accessibility of information about Aiyl Aimak / municipal government budget will lead to higher trust in local government.
- But main issues that must be revealed and solved are related with election procedure and budget process. Effective solving these problems significantly increases trust in local government
